Dear Friends,

In the following lines I wish to put across my views regarding a topic that will be discussed at the upcoming board meeting of the Claims Conference, i.e. the call to reduce Claims Conference allocations for Holocaust remembrance. Although I am not a member of the Claims Conference board of directors, it is important to me to express my opinion on this vital matter, both as a Jew and a Holocaust survivor, and I prefer that my words be heard and not represented by those whose position does not reflect my own nor that of my friends.

As a Holocaust survivor, it is important for me to stress that the commitment that the Claims Conference has taken upon itself – preserving the memory of the Holocaust – is a moral responsibility of the highest order, and you as members of the board must constantly make sure yourselves that you are fulfilling your obligation.

This commitment, is not simply an obligation, it is the last will of the owners of these Holocaust era funds - the victims.

On their behalf and, if you will allow me, on our behalf - the survivors - we must ensure remembrance of the Shoah and its lessons for eternity. We must document what happened, record the names of the victims, the communities and their heritage. The coming generations must be taught about what happened in all its aspects, and thus ensure as much as possible that such phenomena will not recur.

This is not only a commitment to those who perished, but also to ourselves - the living.

Today, we are witnessing a rising wave of antisemitism, misrepresentation of the Holocaust in verbal attacks against the State of Israel, and increasing tendencies of Holocaust denial and minimalization, all this less than sixty years since the end of the horrific Shoah that was perpetrated against our nation.
